## Cannabis concerns fielded by Senator Tiver during EHC council meeting

EGG HARBOR CITY, N.J.—With the recent changes in the Senatorial district lines, representatives across the state are reaching out to new additions to their districts. One such meet and greet was conducted at the recent Egg Harbor (EHC) city council meeting on April 25.

“I just want you to know I’m here to help,” District 8 Senator Latham Tiver said while addressing EHC council.

During his remarks, Mayor Dr. Lisa Jiampetti spoke to the senator about a growing concern with Delta-8 and Delta-9 tetrahydrocannabinol (THC). Both variants are legal in the state of New Jersey as long as the product contains no more than 0.3% THC, a restriction outlined in the 2018 Farm Bill.

Delta-8 THC is typically manufactured in concentrated amounts from hemp-derived CBD, a less potent ingredient compared to Delta 9 THC.

In May 2022 the Food and Drug Administration (FDA), issued warning

letters to five manufacturers of Delta-8 THC products addressing misbranding including a lack of adequate instructions on use of products and marketing practices implemented by the manufacturers.

Delta-9 THC is the more notable intoxicating component of cannabis plants. The effects of consumption beyond certain thresholds in individuals create a typical experience know as a “high.” Manufacturers of Delta THC products market their use for treating or mitigating symptoms of certain medical conditions or diseases. The FDA has only approved two synthetic THC products. Dronabinol and nabilone were FDA approved for use to alleviate chemotherapy-induced nausea and vomiting. The latter product is also used to aid in appetite improvements for patients with AIDS.

The relatively new harvesting of legal marijuana is creating a mix of praises from users coupled with concerns due to a lack of research on the short- and long-term effects of the growing market. Those growing concerns are part of the

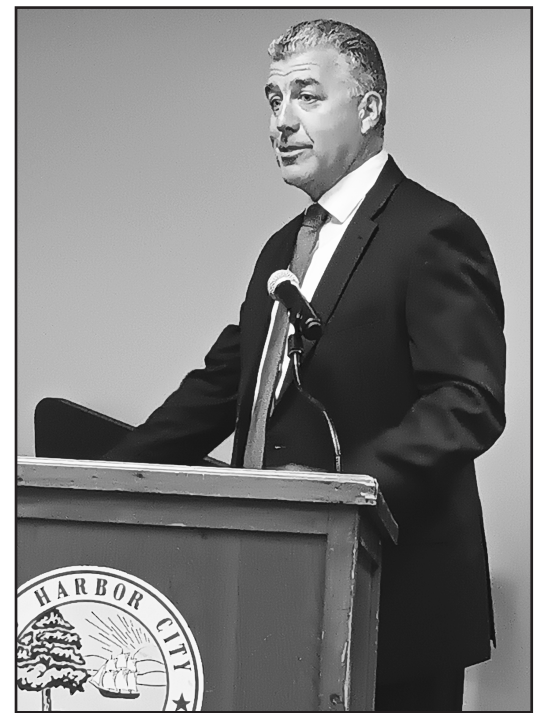
issues Jiampetti was asking Tiver to investigate.

Tiver assured the council that he would follow up on the issue when returning to his office.

Senate Bill No. 3470 was sponsored by Senator DeClan O’Scanlon, Jr. and Senator Teresa Ruiz and introduced on January 12, 2023 and since amended to include measures to oversee cannabis manufacturing and sales.

An amendment to this New Jersey statutory law authorizes The Cannabis Regulatory Commission, to track, through a registration process, hemp-derived cannabinoid product manufactured outside the New Jersey regulatory structure, and establish other safety and testing requirements, an act developed to address certain hemp-derived cannabinoids and amending and supplementing various parts of the statutory law.

The rapid legalization and ongoing manufacturing developments will continue to see legislation addressing ever-changing concerns over the harvest of cannabis and related products.

# Winslow Twp. BOE approves new device policy

The Winslow Twp. Board of Education met on May 8 at the Winslow Twp. Board of Education Administration Building. The board approved Policy #5516 Use of Electronic Devices and will take affect throughout the district.

The board provided the second reading of Policy #5516, Use of Electronic Devices. This policy was revised after the first reading from several weeks ago was tabled. Community members voiced their opinions that the policy needs to be reformed. During the April 24 meeting, the first reading of the policy was approved by the board.

The updated policy will include several courses of actions before students ultimately receive suspensions and loss of privileges such as unable to participate in prom and commencement.

A question was raised about whether past suspensions would be erased from students' records. Superintendent H. Major Poteat indicated that records would not be expunged as the incidents had already happened.

"It will not be removed because in as much as it was in effect, the old policy would have superseded it anyway. The point is, a violation did occur, student was punished for the violation. As a matter of fact, under that policy

they were punished less than they would have had they been suspended for the four days. So no, we are not going to go back and expunge records for the violations that did occur," Poteat said.

Board member Rebecca Nieves brought up that the policy will still allow technology already used by teachers in the classroom without repercussion. This includes smartboards, laptops, headphones and more, so long as the curriculum includes that device. That will remain and will not be affected by Policy #5516.

The second reading of the electronics policy was approved. Staff throughout the school district will be informed of the updated electronic device policy along with other policies by the administration.

An issue that was brought up by Poteat was a connectivity issue, which had affected the whole school district.

"We have been having some problems with connectivity during our state assessment throughout the district. As a result, the Department of Education has halted all testing due to these technology issues with Pearson along with some of our other providers. We are in contact with our internet provider as well as our firewall provider. We conducted a district wide infrastructure test today (May 8) around 1 o'clock, maybe 1,400 students participated to try and identify the problem and we are waiting for the result of that test," Poteat said.

Though there have been connectivity issues that affects

certain elements such as testing, classes have proceeded like normal as it does not affect the actual computers in the district.

There was a miscommunication between the Citizen's Advisory Committee (CAC) and the Board of Education in regard to relaying the minutes ahead of the meeting. The CAC had read the minutes from their meeting to the board and public regarding topics such standardized testing locations for students, questions and concerns regarding the electronic use policy and more. Though these were discussion topics, it was misconstrued as recommendations to the board. It was suggested that the CAC submit all minutes prior to the meeting so that an official response could be made during the meeting.

It was announced that during the next meeting, the Teacher of the Year ceremony will take place. A teacher from each school in the district will be represented that night and one will be named District Teacher of the Year. During last year's ceremony, Virginia Chillari from School 4 was awarded the 2023 District Teacher of the Year.

The next Board of Education meeting will be held on May 22 at the Winslow Twp. Middle School.

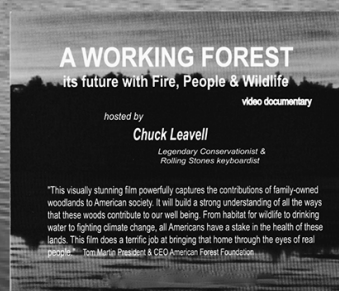

# Egg Harbor City receives \$850,000 grant

EGG HARBOR CITY, N.J.—With five of nine councilors in attendance, the May 9 meeting of the Egg Harbor City (EHC) council moved rather quickly. Top issues at the meeting included the announcement from the mayor that the city secured a \$850,000 grant from the New Jersey Urban and Community Forestry Program. According to Mayor Dr. Lisa Jiampetti, \$400,000 of the grant is earmarked for planting trees, \$400,000 for maintaining trees and \$50,000 is to conduct a tree inventory.

During Jiampetti's report she also announced that the city-wide cleanup day removed almost four tons of trash from the city. The effort saw over 340 volunteers show up to take part in the cleanup. She stated that the event was a huge success due to the excellent participation from staff and citizens.

The city also put a new streetsweeper into operations recently purchasing a unit to replace the existing one. The total cost for the new unit was \$300,781, including extra accessories like a hose for more direct cleanouts. The money came from the sale of the water treatment for the city, money allocated as per a detailed plan provided to the Department of Community Affairs.

Councilor Mason Wright announced

that Max Melton, former Egg Harbor City resident was recently drafted No. 43rd overall in the recent NFL draft. Melton played as a cornerback at Rutgers University and will be heading to Arizona to play for the Cardinals.

EHC Police Chief Marcella Aylwin's report to council included five thefts, six motor vehicle crashes, 39 traffic stops, eight total summonses, three arrests, seven business alarms, four residential alarms, 150 crime prevention activities, two criminal shift calls, seven domestic calls, 23 EMS incidents, 10 firearms applications, six follow-ups, 290 more property checks and five public service calls.

The three arrests included Steven M. Grabel, a 69-year-old man from Egg Harbor City arrested by Sergeant Mangold on April 25 for unlawful acts; Daweed M. Jackson, a 23-year-old man from Egg Harbor City arrested by Officers White and Rosenberger on May 5 for driving while suspended for DWI; and Patrick C. Pursell, a 55 year-old man from Egg Harbor City arrested on May 5 by Officers Defeo and White for terroristic threats.

The chief informed the council that three new vehicles have been fully updated and are ready for service. Aylwin also announced that concentrated efforts between May 20 through June 2 for the "Click it or Ticket" efforts of

law enforcement. The Chief explained that increased enforcement, just because it's click-it-or ticket does not mean that there will not be other citations issued. There will be other focused efforts going on throughout the city, including initiatives to reduce shoplifting and jaywalking. The announcement of these focused initiatives are part of the department's pro-active policing.

"The reason I'm telling people about this is because if we don't have to write the tickets and we don't have to respond to accidents, and we don't have to respond to stores or shoplifting, then we are doing our job. It's a preventative thing," Aylwin said. "I'd rather stop somebody from doing something. It's about prevention. So, if we can do what we need to do to prevent that and if people think, oh, they said that they're going to be doing this and it makes them slow down, then fantastic."

The council also passed supporting New Jersey Senate Bill S-2930/A-4045, listed as a Resolution Calling for the Modernization of the Open Public Records Act (OPRA). The bill introduced during the 2024-2025 regular session was proposed to make various changes to the process for accessing government records, appropriating \$8 million for this purpose. OPRA is legislation securing that government records should be readily accessible for inspec-

tion, copying or examination by citizens of New Jersey. The bill is attempting to address perceived abuse of OPRA and the costs to government entities responsible for providing OPRA requested information. Critics of the legislation have expressed concerns that the bill could give lawmakers the power to block information from the public, potentially hindering transparency.

The next Egg Harbor City council meeting will be held on May 23, at the Municipal Complex Meeting Room, 500 London Avenue, Egg Harbor City.
